

# **Constituent Services and Support Coordinator**

## The Mississippi Alliance of Nonprofits and Philanthropy

The Constituent Services and Support Coordinator will develop and maintain strong relationships throughout the state with Alliance members, the Regional Volunteer and Nonprofit Hub Directors, and not-yet-members, through a rigorous process of engagement, identification of needs, network building and customer service. This position will report directly to the Program Director and work collaboratively with staff members, consultants, and partners to help bolster collaboration, foster innovation, and improve performance of nonprofit and philanthropic organizations throughout the state.

## **ESSENTIAL JOB FUNCTIONS:**

- Serve as a conduit between the Alliance, Hub Directors and members throughout the regions to help identify and resolve challenges of non-profit and philanthropic organizations.
- Ensure Regional Hub Directors understand the roles and expectations in connecting local nonprofits and philanthropy to capacity building and training offered through Alliance services.
- Maintain a solid working knowledge of capacity building services and other member benefits available to Alliance members. Be able to articulate the value of these benefits and services and recognize opportunities that can be addressed through membership, programs and services.
- Develop and maintain a strong relationship with each of the Hub Directors, recognizing and acknowledging the critical role they play in customer satisfaction and providing them with exceptional customer service, while working to identify local and regional training needs.
- Work with Alliance Program Director, to develop and maintain a training calendar developed from feedback garnered from Hub Directors that address the organizational development and capacity building needs of nonprofits and philanthropic organizations. All training programs should be clearly linked to *Principles and Standards for Nonprofit & Philanthropic Excellence*.
- Interface, with a customer service orientation, with the MS Hub Network and Hub Directors
  to provide logistical support for trainings and workshops and to ensure that training
  checklists and Training Session Submission forms are completed for all training events and
  required tasks are completed.

- Assist communications team in managing posts to social media outlets, contribute content to newsletters and push electronic alerts to members, not-yet-members and stakeholders to keep them informed of Alliance activities and strategic initiatives.
- Work with Alliance leadership (and contracted program support consultants) to track training-related data, including, but not limited to, attendance for both individuals and organizations, evaluations and profitability of trainings.
- Work with Alliance staff to ensure a high level of internal and external customer satisfaction and measurable Return on Investment.
- Effectively use the *Principles and Standards for Nonprofit & Philanthropic Excellence* to understand and promote behaviors, procedures and processes that ensure the Alliance's ability to demonstrate best practices in the delivery of programs and services.
